DESCRIPTION

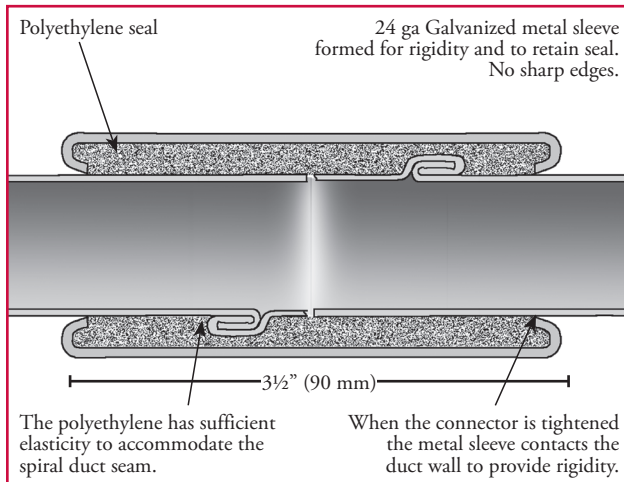
Quick-Sleeve is a band-clamp connection available with a single-bolt connection for 3" through 18" diameter ducts and a double-bolt connection for 4" through 18" diameter ducts.

BASIC USE

To provide a simple, leak-free connection for round ducts used in air-conditioning, ventilation and dust collection systems.

INSTALLATION INSTRUCTIONS

1. Loosen bolt.
2. Insert each duct about halfway into the Quick-Sleeve.
3. Tighten bolt.
